Dra. Rachel Straus, born New York, NY, is a research member, since 2019, with the Universidad de Salamanca's IHMAGINE (Intangible Heritage Music and Gender International Network). A professor at The Juilliard School (2011-18), a contributing writer for the classical musical magazine *Musical America* (2009-present), and an assistant editor at *Amnesty International Magazine USA*, (2006-7) and *Dance Magazine* (2005-6), her current scholarly research focuses on early twentieth century artistic exchanges between dancers, musicians, and writers in the U.S.A. and Europe. She also researches linguistical strategies employed by American performing arts leaders and institutions.
